

LIFEGEM PURCHASE AGREEMENT

I, _____ (NRIC No: _____) hereinafter referred to as the "Purchaser" by signing this agreement hereby agree to the following terms and conditions:-

1. I acknowledge that in order to create a LifeGem, it is necessary to use carbon extracted from a lock of hair or some ashes from of the cremated remains of _____ as been provided by the aforesaid Purchaser.
2. I further agree that any item that has been provided by the Purchases for the creation process should be placed under the care of LifeGem and shall remain the property of LifeGem even after the creation process.
3. The price of the LifeGem created diamond shall be as stated in the Purchase Order Form but will be reduced accordingly if the completed LifeGem is smaller than what is specified in the Purchase Order. However if the LifeGem is larger than what is specified, no additional charge will be imposed.
4. I agree to pay 50% (fifty percent) of the purchase price at the time of the order being accepted by LifeGem and upon signing of the Purchase Agreement and Order. The remaining 50% (fifty percent) will be due and payable upon delivery of the LifeGem.
 - a) In the event of cancellation of order after signing of the Purchase Order and the 50% deposit has been made, but before the commencement of the creation process, the deposit will be refunded. However 10% (ten percent) of the purchase price will be imposed for administrative cost incurred.
 - b) In the event of cancellation of order after the commencement of the creation process, there will be **NO** refund of the deposit. Kindly note that any item that has been provided to LifeGem **WILL NOT BE RETURNED** (Please refer to Para 2 above). However under exceptional circumstances and at the absolute discretion of LifeGem, the items may be returned at the Purchaser's own expense.
5. Under normal conditions, the duration of the creation process is approximately 28 (twenty-eight) weeks for Yellow diamond and 38 (thirty-eight) weeks for Blue diamond. It will also vary from individual requirement.
6. If ring or pendant services are required, a further 2 (two) weeks process time is required.
7. This Agreement/Order will be governed by the relevant judiciary laws of the Republic of China, Taiwan. In the event of any dispute which may arise from this Agreement/Order, both parties mutually agree to submit the issue to the jurisdiction of the Courts of the Taichung District of Taiwan.
